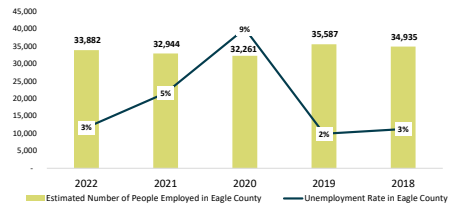
This dashboard is provided as a part of the Town of Vail 2022 Economic Development Strategic Plan and introduces a synopsis of Vail Economic Indicators representing yearly data as of 2022. Summaries are published twice annually as soon as practical after the data has become available, is limited in scope by the availability of data from secondary sources, and is believed to be generally accurate, but not independently verified. DestiMetrics collects lodging performance data from 28 properties in the Vail destination, representing up to 2,600 units and 68.46% of 3,797 total units in the Vail destination

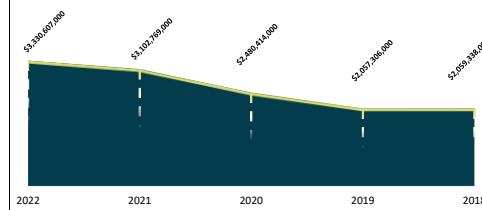

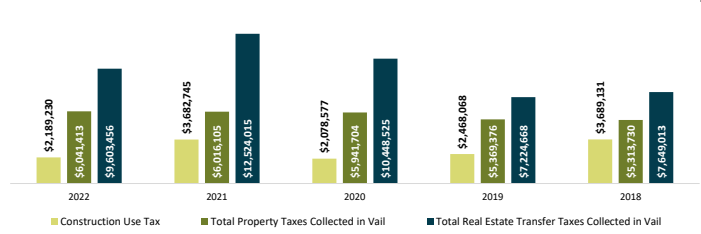
Total Banking Deposits in Eagle County (\$)



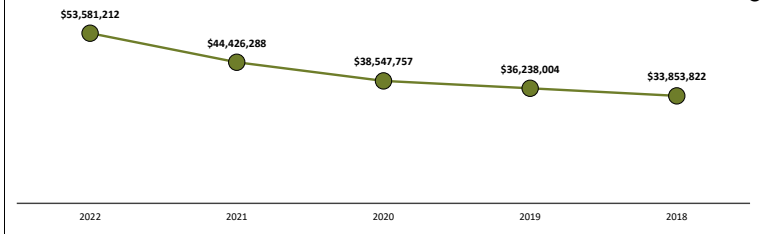
Estimated Full-Time Residents in Vail



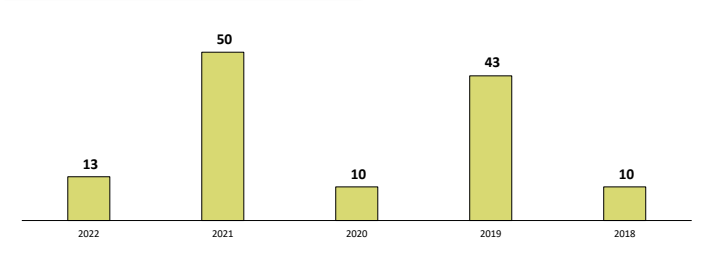
Annual Real Estate and Construction Use Tax Collection



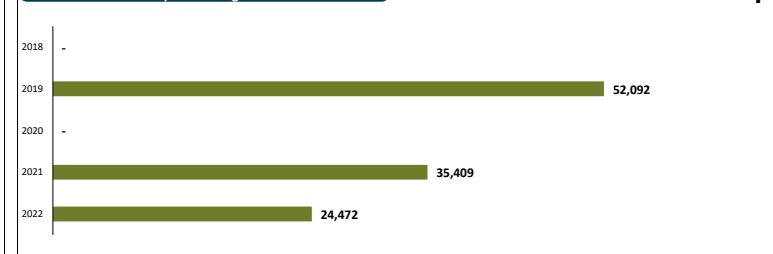
Eagle County General Fund Year-End Balance
